Re: Public Records Act Request 2022-01270

Dear Mike Millen:

This letter is in response to your public records request received in the Attorney General's Office on June 23, 2022, in which you sought records pursuant to the Public Records Act as set forth in Government Code section 6250 et seq.

Specifically, you requested:

"In regards to Penal Code section 11126, all memos, reports, analyses, directors, policies, and procedures which relate to the following: A) The length of time the DOJ uses to begin, and then complete, its initial review of an applicant's record review request; B) The length of time the DOJ uses to make its final correction decision if clarification or information is not needed from an outside agency; C) The length of time the DOJ takes before officially sending a request to an outside agency if the DOJ wishes for said agency to provide clarifying information regarding a record; D) The length of time the DOJ takes, after receiving clarification from an outside agency concerning a record, to process the outside agency's response to the DOJ's request and make a formal correction decision; E) On a monthly basis for the last three years, the number of pending record correction requests more than 30, 60, 90, and 180 days old which were awaiting for action to be taken by the DOJ itself; [F]) Budget Requests for personnel, equipment, and other expenses related to the DOJ's carrying out its duties under Penal Code section 11126; [G]) Department organization related to the DOJ's carrying out its duties under Penal Code section 11126; [H]) All correspondence, notes, and records relating to the process and investigation the DOJ engaged in when analyzing and correcting the records of Dimitar Dimov (CII#A24597939)."

To the extent that you are seeking the respective time frames for items A through E, the California Department of Justice (Department) does not collect or maintain data to the level of specificity you are requesting and has no responsive records for this request. Processing timelines for applicant record review requests are unique per the contents of each request.

To the extent that you are seeking responsive records for item F, the Department does not collect or maintain data to the level of specificity you are requesting, and has no responsive records for this request. The expenses of the duties carried out by the Department under Penal Code section 11126 are not solely tracked by the Department through budget requests, and expenses will vary annually based upon current staffing required to perform the duties and workload fluctuation.

To the extent you are seeking responsive records for item G, the Department has complied with your request and attached the responsive documents. Please note that the following areas are the primary teams that perform under the fingerprinting services and perform updates to criminal history records:

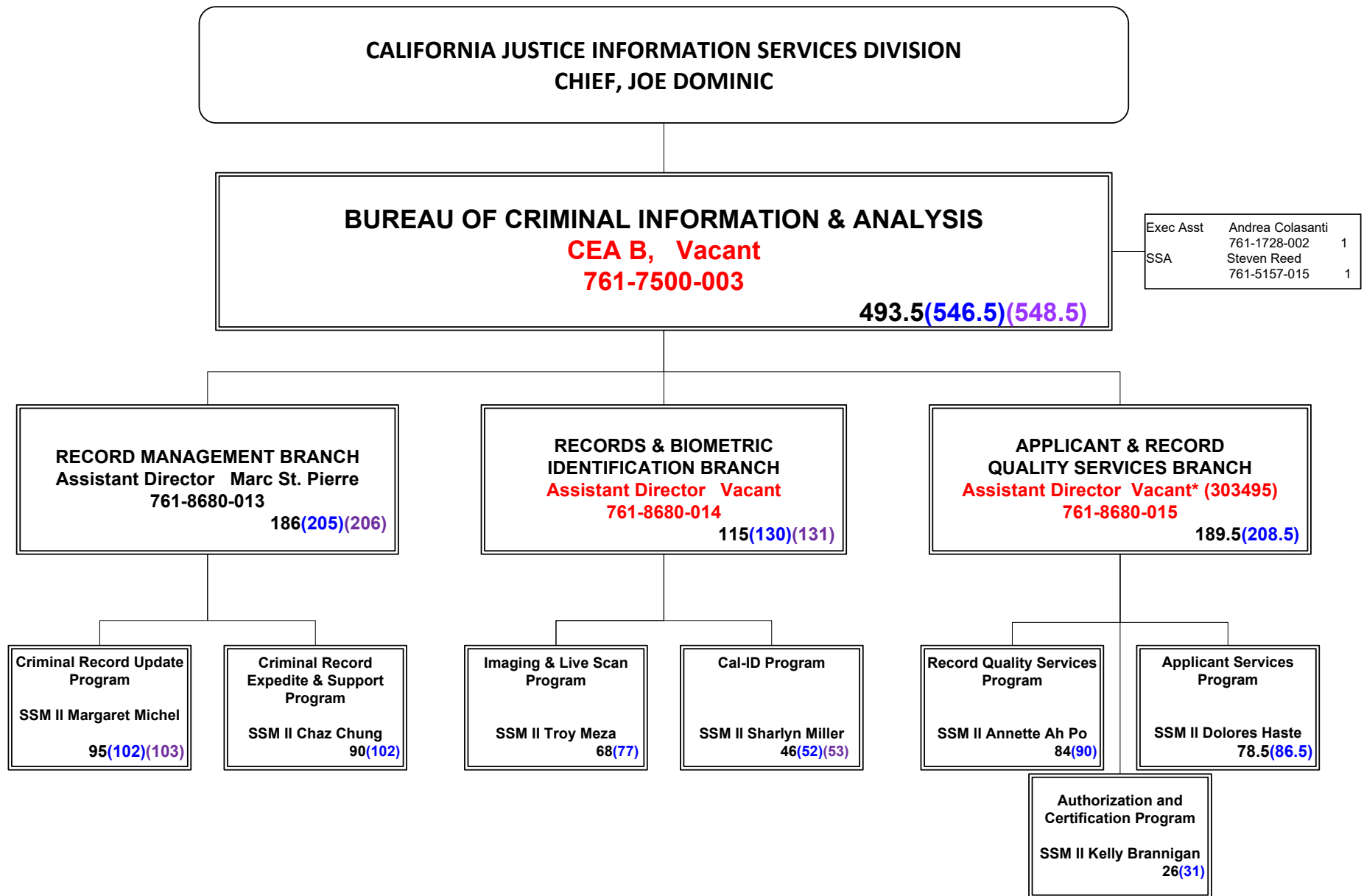
The Department responds to this request only with regard to its own records. If you wish to review records in the custody or control of another state or local agency, you should direct your request for records to that agency.
